OF REMOVAL, AND IT WAS NOT APPEALED, AND IT WAS ACCEPTED
IMMEDIATELY. AS IT WAS REGISTERED IN THE FILES, MAKING THE
ORDER OF REMOVAL EFFECTIVE AT THAT DATE AND NOT ON
FEBRUARY 14/2025. SEE ATTACHMENT. (III)

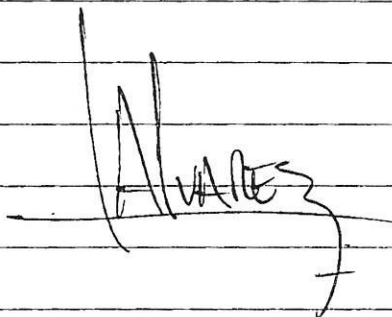
— CONCLUSION —

ON THE DATES OF AUGUST 13TH & 14TH 2024 AND NOVEMBER 14 / 2024 PETITIONER RECEIVED ADMINISTRATIVE FINAL ORDER OF DEPORTATION THEREFORE THE PERIOD OF 90 DAYS TO BE REMOVED FROM THE US BEGINS ON NOVEMBER 14TH, THE SAME DAY THAT THE PETITIONER WAS RELEASED FROM B.O.P CUSTODY, AND TAKEN IN CUSTODY FROM ICE OFFICER ATLANTA AND BROUGHT TO STEWARD DETENTION CENTER IN LUMPKIN, GEORGIA. PETITIONER HAVE BEEN IN CUSTODY TO DATE.

THE PETITIONER ADMITS TO HAVING SUBMITTED THE HABEAS CORPUS APPLICATION IN ADVANCE AND WITH KNOWLEDGE, THE 180-DAY PERIOD WILL HAVE BEEN COMPLETED ON MAY 14 / 2025.
