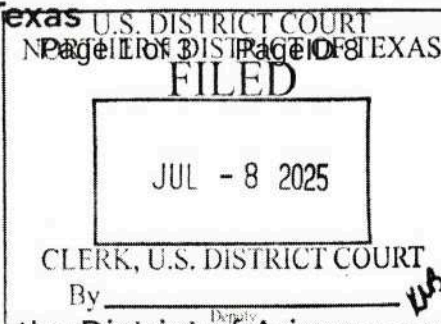

Subject: Request to Return Case to the District of Arizona Due to Petitioner's Transfer Back to Eloy Detention Center

To the Honorable Court,

My name is Dmitrii Gukovskii (A# [REDACTED]). I am the husband of the petitioner, Liubov Kokoreva (A# [REDACTED]), and I respectfully submit this request on her behalf pursuant to the "Next Friend" doctrine, under 28 U.S.C. § 2242.

I hereby inform the Court that on June 30, 2025, U.S. Immigration and Customs Enforcement (ICE) transferred Liubov Kokoreva back to the state of Arizona, where she is currently detained at Eloy Detention Center — the same facility where she was held at the time of filing her original habeas corpus petition before the District of Arizona.

Given that she is no longer within the jurisdiction of the Northern District of Texas, I respectfully request the Court to:

- cease substantive consideration of this case due to lack of jurisdiction;
- and transfer the case back to the United States District Court for the District of Arizona — the proper venue for her current location and original filing.

I also respectfully ask the Court to consider the following:

- this case involves serious violations of the petitioner's rights;
- she was denied protection despite having filed a Form I-589 (Application for Asylum);
- she has faced repeated (at least five) attempted deportations, which have severely worsened her physical and psychological condition;
- and currently, her case remains "suspended" between two jurisdictions, without appropriate judicial review.

In light of the above, I respectfully urge the Court to promptly return the case to the District of Arizona.
