Grounds for Your Challenge in This Petition

GROUND ONE: July 8, 2025 DHS Guidance classified Petitioner under INA 235 as an "applicant for admission" and thus subject to mandatory detention. Individuals classified under INA 236(a) are generally entitled to a bond hearing at the outset of their detention, and are not subject to mandatory detention. On October 15, 2025, an application for bond was filed, but based on the July 8th DHS guidance, it is expected to be denied.

(a) Supporting facts (*Be brief. Do not cite cases or law.*):

Petitioner has been in the U.S. for more than 2 years and has no criminal history. Petitioner was arrested while working at a car wash in Los Angeles, CA over a hundred miles from the border. Prior to July 8, 2025, DHS guidance would have classified Petitioner under INA 236(a) and as being bond eligible. Petitioner should be classified under INA 236 and should be eligible for release on bond subject to an Immigration Judge's discretion.

GROUND TWO: Violation of the 5th Amendment because Mr. Ramirez Lima remains detained without due process. The Government's detention of Petitioner without a bond redetermination hearing to determine whether he is a flight risk or danger to others violates his right to due process.

Mr. Ramirez Lima's classification by DHS and ICE under INA 235 deprives him of the due process protections found in INA 236. Petitioner has a fundamental interest in liberty and being free from official restraint.
