I inquired with ICE and EOIR regarding the failure to notify Petitioner's counsel of the bond hearing and was advised that no counsel had entered an appearance for Petitioner prior to the Court-ordered bond hearing. Given that no attorney was on record, the notice of hearing was served on Petitioner himself two days prior to the bond hearing. A copy of the notice is attached. An attorney has since appeared on his behalf.

Now that counsel for Petitioner has entered an appearance, I have been assured he will be notified of the upcoming bond hearing. I have also requested that the bond hearing be held by the 28th as this Court ordered, although that may run up against this Court's requirement that sufficient notice be provided, given the holiday tomorrow.
