The petitioner, Michael Hailu Mamo, is an non-citizen who filed a Petition for Writ of Habeas Corpus under 28 U.S.C. § 2241 on December 12, 2025. On December 16, 2025, the Court issued the following scheduling order:

ORDER FOR RETURN AND STATUS REPORT, § 2241 PETITION. Within 30 days of the date this Order is posted, Respondent(s) shall show cause why a writ of habeas corpus should not be granted by filing a return as provided in 28 U.S.C. § 2243. Petitioner may file and serve a response no later than 21 days after the return is filed, and Respondent(s) may file and serve a reply no later than 28 days after the return is filed. Signed by Hon. S. Kate Vaughan. (APH)

Under this order, briefing will not be completed until early March 2026.

Yesterday, the Court issued General Order 10-25, in order to “facilitate the prompt adjudication of § 2241 immigration habeas petitions.” That order provides for briefing to be

completed within three weeks. Mr. Mamo seeks to amend the December 16 scheduling order to
