ADDITIONAL TIME TO RESPOND TO
EX PARTE APPLICATION FOR
TEMPORARY RESTRAINING ORDER**

1 Respondents are in receipt of the Court's Minute Order Setting Briefing Schedule
2 on Petitioner's Ex Parte Application for Temporary Restraining Order (Dkt. 6).
3 Petitioner alleges that he has neither his original Iranian birth certificate nor his original
4 Iranian passport and claims that the Iranian consulate requires both original documents
5 to issue a travel document. Dkt. 4 at 2:21-25.

6 Respondents have been removing Iranian nationals to Iran. However, Respondents
7 request additional time to investigate Petitioner's allegations that he or Respondents do
8 not have his original birth certificate and the status of the issuance of Petitioner's travel
9 documents to Iran.

10 Respondents respectfully request an additional 14 days from today, through
11 January 6, 2026, to further respond to the Ex Parte Application for Temporary
12 Restraining Order so that more information concerning the status of Petitioner's travel
13 documents can be provided.
