Petitioner David Betancourt Gomez, proceeding *pro se*, respectfully requests that the Court grant **designated online (CM/ECF) access** to a support person for the limited purpose of assisting Petitioner in reviewing filings, receiving electronic notices, and preparing court submissions in this matter.

I. BASIS FOR REQUEST

1. Petitioner is currently **detained in ICE custody**, which substantially limits his ability to access court filings, electronic notices, and legal research resources in a timely manner.

2. Petitioner is proceeding **without counsel** and must comply with all filing deadlines, procedural rules, and Court orders without the benefit of appointed representation.
3. Due to detention-related restrictions, including limited library access and delays in receiving mailed court documents, Petitioner requires assistance to meaningfully participate in these proceedings.
4. The requested access is **for support purposes only** and is not intended to substitute for legal representation or to permit the support person to appear as counsel.

II. IDENTIFICATION OF SUPPORT PERSON

- Assist Petitioner in organizing filings and complying with deadlines

Petitioner understands and affirms that:

- The support person **will not file documents**, sign pleadings, or appear on Petitioner's behalf unless separately authorized by the Court
- Petitioner **remains solely responsible** for all filings and compliance with Court rules and orders

- This request does **not** seek attorney privileges or confidential access beyond what the Court permits

IV. GOOD CAUSE

Good cause exists for this request because:

- Petitioner is **civily detained** and faces significant logistical barriers to court access
- The case involves **constitutional liberty interests** and ongoing detention
- Granting limited online access will promote **judicial efficiency**, reduce delays, and ensure Petitioner receives timely notice of Court orders and filings

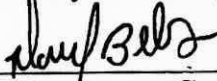
Courts routinely permit reasonable accommodations for pro se detainees to ensure meaningful access to the courts.
