9 I, Bradley A. Hayes, pursuant to 28 U.S.C. § 1746, hereby declare as follows:

- 10 1. I am a Supervisory Detention and Deportation Officer (“SDDO”) employed by the U.S.
11 Department of Homeland Security (“DHS”), U.S. Immigration and Customs
12 Enforcement (“ICE”), Enforcement and Removal Operations (“ERO”). I am currently
13 assigned to the Anchorage Sub-Office in Anchorage, Alaska, under the ERO Seattle
14 Field Office.
- 15 2. In my official capacity, I manage the detention and removal of noncitizens, including
16 executing removal orders, coordinating with foreign governments, and maintaining case
17 records in official DHS systems. I make this declaration based on my review of those
18 systems and records, and on my familiarity with the case of Son Hoang Vu
19 (“Petitioner”).
- 20 3. I have previously given declarations on January 20, 2026, February 03, 2026, and
21 February 26, 2026, about this case. Now, through this declaration I am providing
22 additional update.
- 23 4. As per the Headquarters Removals and International Operations recent update on March
24 4, 2026, Petitioner’s travel document will be issued on March 6, 2026.
