INTRODUCTION

1. This case challenges the unlawful re-detention of the petition, N-S-, who entered the United States on December 17, 2023, to seek asylum. Shortly after his entry, he was released on parole and subsequently filed his asylum application based on his fear of persecution in Russia.
2. Since his release on parole, Petitioner has faithfully complied with the check-in requirements imposed by Immigration & Customs Enforcement (ICE) as part of his release.
3. Despite this compliance, on December 27, 2025, ICE re-detained Petitioner after ostensibly contacting Petitioner to repair an error in his monitoring device. Petitioner was transferred to the Northwest ICE Processing Center (NWIPC) in Tacoma, Washington, where he remains detained.
4. Before re-detaining him, Respondents did not provide Petitioner with any written notice explaining the basis for the revocation of his release. Nor did they provide a hearing before a neutral decisionmaker where ICE was required to justify the basis for re-detention or explain why Petitioner is a flight risk or danger to the community.
5. Due process demands such a hearing *prior* to the government's decision to terminate a person's liberty. *See E.A.T.-B. v. Wamsley*, --- F. Supp. 3d --- No. C25-1192-KKE, 2025 WL 2402130 (W.D. Wash. Aug. 19, 2025).
6. By failing to provide such a hearing, Respondents have violated Petitioner's constitutional right to due process. Accordingly, this Court should grant the instant petition for a writ of habeas corpus and order his immediate release. *See id.* at *6 (ordering immediate release because "a post-deprivation hearing cannot serve as an

adequate procedural safeguard because it is after the fact and cannot prevent an erroneous deprivation of liberty”).

JURISDICTION

7. This action arises under the Constitution of the United States and the Immigration and Nationality Act (INA), 8 U.S.C. § 1101 et. seq.

8. This Court has subject matter jurisdiction under 28 U.S.C. § 2241 (habeas corpus), 28 U.S.C. § 1331 (federal question), and Article I, § 9, cl. 2 of the United States Constitution (Suspension Clause).

9. This Court may grant relief under the habeas corpus statutes, 28 U.S.C. § 2241 et. seq., the Declaratory Judgment Act, 28 U.S.C. § 2201 et. seq., and the All Writs Act, 28 U.S.C. § 1651.

10. In addition, "a federal court always has jurisdiction to determine its own jurisdiction," including its own subject-matter jurisdiction. *Brownback v. King*, 592 U.S. 209, 218-19 (2021) (quoting *United States v. Ruiz*, 536 U.S. 622, 628 (2002)).

11. Unless the assertion of jurisdiction is frivolous, the court has the power to preserve existing conditions while it determines its own authority to grant injunctive relief. See *United States v. United Mine Workers of America*, 330 U.S. 258, 293 (1947). Such an order is valid unless and until overturned, even when the issuing court lacks subject-matter jurisdiction to determine the underlying action's merits. *Id.* at 293-94.

VENUE

12. Venue is proper because Petitioner is in Respondents' custody at the NWIPC in Tacoma, Washington. Pursuant to *Braden v. 30th Judicial Circuit Court of Kentucky*, 410 U.S. 484, 493–500 (1973), venue lies in the judicial district in which Petitioner is

1 currently in Custody.

2 13. Venue is also properly in this Court pursuant to 28 U.S.C. § 1391(e) because
3 Respondents are employees, officers, and agencies of the United States, and because a
4 substantial part of the events or omissions giving rise to the claims occurred in the
5 Western District of Washington.

6 **REQUIREMENTS OF 28 U.S.C. § 2243**

7 14. The Court must grant the petition for writ of habeas corpus or issue an order to show
8 cause (OSC) to the Respondents “forthwith,” unless Petitioner is not entitled to relief. 28
9 U.S.C. § 2243. If an OSC is issued, the Court must require Respondents to file a return
10 “within three days unless for good cause additional time, not exceeding twenty days, is
11 allowed.” *Id.*

12 15. Habeas corpus is “perhaps the most important writ known to the constitutional law . . .
13 affording as it does a swift and imperative remedy in all cases of illegal restraint or
14 confinement.” *Fay v. Noia*, 372 U.S. 391, 400 (1963). “The application for the writ
15 usurps the attention and displaces the calendar of the judge or justice who entertains it
16 and receives prompt action from him within the four corners of the application.” *Yong v.*
17 *I.N.S.*, 208 F.3d 1116, 1120 (9th Cir. 2000) (citation omitted); see also *Van Buskirk v.*
18 *Wilkinson*, 216 F.2d 735, 737–38 (9th Cir. 1954) (Habeas corpus is “a speedy remedy,
19 entitled by statute to special, preferential consideration to insure expeditious hearing and
20 determination.”).

21 16. Petitioner is “in custody” for the purpose of 28 U.S.C. § 2241 because he is in
22 Respondents’ custody at NWIPC.

1 17. Petitioner, N-S-, is an adult citizen of Russia. He is detained at the NWIPC.

2
3 **RESPONDENTS**

4 18. Respondent Laura Hermosillo is the Field Office Director for the Seattle Field Office,
5 Immigration and Customs Enforcement and Removal Operations ("ICE"). The Seattle
6 Field Office is responsible for local custody decisions relating to non-citizens charged
7 with being removable from the United States, including the arrest, detention, and custody
8 status of noncitizens. The Seattle Field Office's area of responsibility includes Alaska,
9 Oregon, and Washington. Consequently, Laura Hermosillo is a legal custodian of
10 Petitioner and is sued in her official capacity.

11 19. Respondent Bruce Scott is employed by the private corporation The Geo Group, Inc., as
12 Warden of the NWIPC, where Petitioner is detained. He has immediate physical custody
13 of Petitioner. He is sued in his official capacity.

14 20. Respondent Todd Lyons is the Acting Director of ICE, and as such is responsible for the
15 means by which the immigration laws of the United States are enforced. Todd Lyons is
16 sued in his official capacity.

17 21. Respondent Kristi Noem is the Secretary of Homeland Security. As such she is
18 responsible for the actions of that department, its subagencies, and its officers and
19 personnel. Kristi Noem is sued in her official capacity.

20 22. Respondent Pamela Bondi is the Attorney General of the United States, and as such has
21 responsibility for the conduct and operations of the Department of Justice and all of its
22 officers and personnel, including the Executive Office for Immigration Review. Pamela
23 Bondi is sued in her official capacity.

23. Respondent U.S. Department of Homeland Security is the federal agency that has authority over the actions of ICE. It is under the direction of respondent Kristi NOEM.

24. Respondent U.S. Immigration and Customs Enforcement is an agency of Respondent, U.S. Department of Homeland Security, and is under the direction of respondent Todd LYONS.

MOTION TO PROCEED ANONYMOUSLY

25. Parties may proceed anonymously when special circumstances justify secrecy. *Does I thru XXIII v. Advanced Textile Corp.*, 214 F.3d 1058, 1067 (9th Cir. 2000). In the Ninth Circuit, parties may use pseudonyms “in the unusual case when nondisclosure of the party's identity is necessary to protect a person from harassment, injury, ridicule or personal embarrassment.” *Id.* at 1067-68 (citation, ellipsis and internal quotes omitted). A party may preserve anonymity in “in special circumstances when the party's need for anonymity outweighs prejudice to the opposing party and the public's interest in knowing the party's identity.” *Id.* at 1068.

26. Petitioner seeks leave to proceed anonymously because public identification creates a risk of retaliatory physical harm due to Petitioner's immigration status in the United States, and the nature of Petitioner's claim is sensitive and highly personal. He alleges wrongdoing on the part of the Department of Homeland Security and fears that these allegations could lead to retaliation against the Petitioner and his family.

FACTUAL BACKGROUND

27. Petitioner is a 24-year-old citizen and national of Russia.

1 28. Petitioner fled Russia to seek asylum and related protections from persecution and torture
2 in the United States. He fled Russia with his spouse, with whom Petitioner resided in
3 Vancouver, WA and for whom Petitioner provided prior to his detention.

4 29. On or about December 17, 2023, Petitioner came to or near the port of entry at Calexico,
5 CA to seek asylum. That same day, Respondents arrested and detained Petitioner and
6 initiated expedited removal proceedings under 8 U.S.C. § 1225(b)(1).

7 30. Petitioner's spouse was released from custody.

8 31. After a Credible Fear Interview (CFI) on January 10, 2024, Respondents determined that
9 Petitioner had a credible fear of persecution or torture in Russia. Accordingly,
10 Respondents rescinded his expedited removal order and commenced removal
11 proceedings under 8 U.S.C. § 1229a, serving a Notice to Appear on January 18, 2024.

12 32. On January 25, 2024, Respondent DHS paroled Petitioner from its custody into the
13 United States under 8 U.S.C. § 1182(d)(5). As a condition of Petitioner's release, he was
14 required to enroll in the Intensive Supervision Appearance Program (ISAP), a program
15 operated by a private contractor that ICE uses to monitor released noncitizens.

16 33. Following his release, on December 12, 2024, Petitioner timely filed his application for
17 asylum, withholding of removal, and Convention Against Torture Protection with
18 the Portland Immigration Court. The Portland Immigration Court scheduled him for a
19 final hearing in his case on September 20, 2029, at 1:00PM before Immigration Judge
20 Steven Caley.

21 34. To the best of his knowledge, Petitioner complied with all ISAP requirements following
22 his release. These requirements included phone and video check-ins through the ISAP
23 mobile phone application (ISAP app).

1 35. After the Petitioner traveled to Texas, ICE chose to place a monitoring bracelet on him.

2 This is despite, to the best of his knowledge, the Petitioner not being subject to any
3 restrictions on interstate travel under the conditions of his parole.

4 36. On December 27, 2025, Petitioner received a phone call from individuals who identified
5 themselves as ICE. ICE told the Petitioner that they were at his domicile and that he
6 needed to open the door and let them in. Petitioner informed ICE officers that he was not
7 home at the time. ICE officers told Petitioner they would meet him at a different location
8 and that his monitoring device was malfunctioning and needed to be repaired.

9 37. Petitioner agreed to meet ICE at a retirement home where his friend ("Jimmy") lives and
10 traveled to that location.

11 38. When ICE arrived at Jimmy's address, ICE proceeded to detain Petitioner. Petitioner
12 asked to see ICE's arrest warrant. ICE ignored this request and proceeded to detain
13 Petitioner.

14 39. In the process of detaining him, ICE threw Petitioner to the ground and placed him in
15 handcuffs.

16 40. Prior to his re-detention, Petitioner did not receive written notice of the reason for his
17 re-detention.

18 41. Prior to Petitioner's re-detention, ICE did not provide notice of the revocation of his
19 parole, as required by 8 C.F.R. § 212.5(e)(2).

20 42. Prior to Petitioner's re-detention, he did not receive a hearing before a neutral
21 decisionmaker to determine if his re-detention is justified.

LEGAL FRAMEWORK

43. Under current caselaw that governs the immigration court system, the mandatory detention scheme under 8 U.S.C. § 1225(b)(1) applies to individuals who are placed in expedited removal proceedings, pass a CFI, and are subsequently placed in removal proceedings. *See Matter of M-S-*, 27 I. & N. Dec. 509 (A.G. 2019). Such individuals are subject to detention without any bond hearing until the conclusion of their proceedings unless DHS releases them on parole. *See id.* at 510, 518–19.
44. However, once released, due process requires that a person like Petitioner receive a hearing before a neutral decisionmaker to determine whether any re-detention is justified, and whether the person is a flight risk or danger to the community.
45. “Freedom from imprisonment—from government custody, detention, or other forms of physical restraint—lies at the heart of the liberty protected by the Due Process Clause.” *Zadvydas v. Davis*, 533 U.S. 678, 690 (2001). As this Court recently recognized, this is “the most elemental of liberty interests.” *E.A.T.-B.*, 2025 WL 2402130, at *3 (citation modified).
46. Consistent with this principle, individuals released on parole or other forms of conditional release have a liberty interest in their “continued liberty.” *Morrissey v. Brewer*, 408 U.S. 471, 482 (1972).
47. Such liberty is protected by the Fifth Amendment because, “although indeterminate, [it] includes many of the core values of unqualified liberty,” such as the ability to be gainfully employed and live with family, “and its termination inflicts a ‘grievous loss’ on the [released individual] and often on others.” *Id.*

1 48. To guarantee against arbitrary re-detention and to guarantee the right to liberty, due
2 process requires “adequate procedural protections” that ensure the government’s asserted
3 justification for a noncitizen’s physical confinement “outweighs the individual’s
4 constitutionally protected interest in avoiding physical restraint.” *Zadvydas*, 533 U.S. at
5 690 (citation modified).

6 49. Due process thus guarantees notice and an individualized hearing before a neutral
7 decisionmaker to assess danger or flight risk before the revocation of an individual’s
8 release. *Goldberg v. Kelly*, 397 U.S. 254, 267 (1970) (“The fundamental requisite of due
9 process of law is the opportunity to be heard . . . at a meaningful time in a meaningful
10 manner.” (citation modified)); *see also, e.g., Morrissey*, 408 U.S. at 485 (requiring
11 “preliminary hearing to determine whether there is probable cause or reasonable ground
12 to believe that the arrested parolee has committed...a violation of parole conditions” and
13 that such determination be made “by someone not directly involved in the case” (citation
14 modified)).

15 50. Several courts, including this one, have recognized that these principles apply with
16 respect to the re-detention of the many noncitizens that DHS has recently begun taking
17 back into custody, often after such persons have been released for months and years.

18 51. For example, in *E.A. T.-B.*, this Court applied the *Mathews v. Eldridge*, 424 U.S. 319
19 (1976), framework to hold that even in a case where the government argued mandatory
20 detention applied, a person’s re-detention required a hearing.

21 52. In applying the three *Mathews* factors, this Court held that the Petitioner had
22 “undoubtedly [been] deprive[d] . . . of an established interest in his liberty,” *E.A. T.-B.*,
23 2025 WL2402130, at *3, which, as noted, “is the most elemental of liberty interests,” *id.*

(citation modified). The Court further explained that even if detention was mandatory, the risk of erroneous deprivation of liberty without a hearing was high because a hearing serves to ensure that the purposes of detention—the prevention of danger and flight risk—are properly served. *Id.* at *4–5. Finally, the Court explained that “the Government’s interest in re-detaining non-citizens previously released without a hearing is low: although it would have required the expenditure of finite resources (money and time) to provide Petitioner notice and hearing on [ISAP] violations before arresting and re-detaining him, those costs are far outweighed by the risk of erroneous deprivation of the liberty interest at issue.” *Id.* at *5. As a result, this Court ordered the Petitioner’s immediate release. *Id.* at *6.

53. This Court’s decision in *E.A. T.-B.* is consistent with many other district court decisions addressing similar situations. *See, e.g., Valdez v. Joyce*, No. 25 CIV. 4627 (GBD), 2025 WL 1707737 (S.D.N.Y. June 18, 2025) (ordering immediate release due to lack of pre-deprivation hearing); *Pinchi v. Noem*,--- F. Supp. 3d ---, No. 5:25-CV-05632-PCP, 2025 WL 2084921 (N.D. Cal. July 24, 2025) (similar); *Maklad v. Murray*, No. 1:25-CV-00946 JLT SAB, 2025 WL 2299376 (E.D. Cal. Aug. 8, 2025) (similar); *Garcia v. Andrews*, No. 1:25-CV-01006 JLT SAB, 2025 WL 2420068 (E.D. Cal. Aug. 21, 2025) (similar).

54. The same framework and principles apply here and compel Petitioner’s immediate release.

CLAIM FOR RELIEF

Violation of Fifth Amendment Right to Due Process

Procedural Due Process

55. Petitioner restates and realleges all paragraphs as if fully set forth here.

56. Due process does not permit the government to strip Petitioner of his liberty without written notice and a hearing before a neutral decisionmaker to determine whether re-detention is warranted based on danger or flight risk. *See Morrissey*, 408 U.S. at 487–88. Such written notice and a hearing must occur prior to any re-detention.

57. Respondents revoked Petitioner’s release and deprived him of liberty without affording him any written notice or meaningful opportunity to be heard by a neutral decisionmaker prior to his re-detention.

58. Accordingly, Petitioner’s re-detention violates the Due Process Clause of the Fifth Amendment.

PRAYER FOR RELIEF

WHEREFORE, Petitioner respectfully requests that this Court:

- (1) Assume jurisdiction over this matter;
- (2) Issue an Order to Show Cause ordering Respondents to show cause within three days as to why this Petition should not be granted as required by 28 U.S.C. § 2243;
- (3) Issue a Writ of Habeas Corpus ordering Respondents to release Petitioner from custody immediately and permanently enjoining his re-detention absent written notice and a hearing prior to re-detention where Respondents must prove by clear and convincing

evidence that he is a flight risk or danger to the community and that no alternatives to detention would mitigate those risks;

(4) Declare that Petitioner's detention without an individualized determination before a neutral decisionmaker violates the Due Process Clause of the Fifth Amendment;

(5) Award Petitioner attorney's fees and costs under the Equal Access to Justice Act, and on any other basis justified under law; and

(6) Grant any further relief this Court deems just and proper.
