MOTION FOR EMERGENCY HEARING ON PETITIONER'S
PETITION FOR WRIT OF HABEAS PURSUANT TO § 2241

COMES NOW, Pro se Petitioner, Hamid Samadi, hereby motions this Honorable Court for an Emergency Hearing for a Writ of Habeas Corpus, and present the following:

Petitioner believes that his detention violates his constitutional rights (he entered legally, was present leggally for years, and was under OSUP ^{when} was he was detained), and is beyond the period stated in *Zadvydas v. Davis*, 533 U.S. 678 (2001). Along with the citation provided in the Petition, Petitioner also provides the following decisions of the sister courts of this Circuit (below). He respectfully requests that the Court grant the same so that the petitioner would be heard at the first available opportunity before this Honorable Court. He is already been detained for ~~nearly~~ 5 months and 14 days.

Hernandez v. Blanche, 2026 U.S. Dist. LEXIS 100994*, LX 292919 (Mid. Fla. May 7, 2026) says "Alien unlawful inside the country fall under § 1226. See *Fonseca v. Ripa* No. 3:26-CV-309-MMH-MCR U.S. Dist LEXIS 87078, 2026 WL 1072778 (M.d. Fla. Apr. 21, 2026)... (Finding immediate release to be the appropriate remedy based on the government's failure to argue in the alternative... See also *Roblero v. Warden, Fla. Baker Corr. Inst.*, 2026 U.S. Dist LEXIS 100979 (Mid Fla. Jackson May 7, 2026), see *Pineda Chalen v. U.S. Dept of Homeland Security*, 2026 (U.S. Dist LEXIS 100978 (Mid Fla, Ft Myers, May 7, 2026) Using a different arugment than above to research the same conclusion.

Regarding removal to Mexico - DGS own deputy Filed Director says: in her declaration: *Rodriguez-Romero, Et Al v. Ladwig, EtAl*, 25-1106-JWD-EWD (Mid Dist La December 5, 2025), said: "Mexico is now accepting 3rd country removal of individuals over the age of sixty..." Decl. Lisa D. Fruge-Prudhome Parg 15.
