DECLARATION OF
IAN BLOOM

I, Ian Bloom, pursuant to 28 U.S.C. § 1746, hereby declare as follows:

1. I am a Deportation Officer employed by the United States Department of Homeland Security (“DHS”), United States Immigration and Customs Enforcement (“ICE”), Office of Enforcement and Removal Operations (“ERO”). I am currently assigned to the ERO office at the Northwest ICE Processing Center (“NWIPC”) in Tacoma, Washington.
2. I am familiar with the case of Petitioners Angelo Arrioja Blanco, Kairolis Avariano Marrero, Dinesh NLN (no last name), Rosario Faya Falla, and Angel Tenias. I make this declaration based upon my personal and professional knowledge, obtained from various records and systems maintained by ICE in the regular course of business. I provide this declaration based on the best of my knowledge, information, belief, and reasonable inquiry in the above-captioned case.

1 3. Petitioner Angelo Arrioja Blanco was released from ICE custody on February 27, 2026, at or
2 about 3:35 p.m. on an Order of Release on Recognizance ("OREC"). He was not required to post
3 bond and was not enrolled in Alternatives to Detention ("ATD") GPS monitoring.

4 4. Petitioner Kairolis Avariano Marrero was released from ICE custody on February 27, 2026,
5 at or about 3:35 p.m. on OREC. She was not required to post bond and was not enrolled in ATD.

6 5. Petitioner Dinesh NLN was released from ICE custody on February 27, 2026, at or about
7 3:46 p.m. on OREC. He was not required to post bond and was not enrolled in ATD.

8 6. Petitioner Rosario Faya Falla was released from ICE custody on February 27, 2026, at or
9 about 3:55 p.m. on OREC and ATD. He was not required to post bond.

10 7. Petitioner Angel Tenias was released from ICE custody on February 27, 2026, at or about
11 3:35 p.m. on OREC. He was not required to post bond and was not enrolled in ATD. Portland ERO
12 subsequently enrolled Petitioner on ATD on March 2, 2026.
