**MOTION FOR TEMPORARY RESTRAINING ORDER,
AND
INJUNCTIVE RELIEF**

TEMPORARY RESTRAINING ORDER

Petitioner-Plaintiff Luis Alberto Corado-Serrano moves this court *ex parte* for a Temporary Restraining Order that would, among other things, require his immediate release from his ongoing detention by agents of Immigration and Customs Enforcement (ICE) and prohibit his re-arrest without pre-detention hearing before an "IJ" Immigration judge at which ICE establishes by clear and convincing evidence that his detention is necessary to prevent hi FlightRisk or Protect the Public.

Background:

The evidence before this Court establishes that Luis Alberto Corado-Serrano is a 20- year-old from Guatemala who came into the United States on 7-10-2022. Petitioner came into the United States alone for a better future. Petitioner left everybody in his family in Guatemala because he had become a victim of the Gang Violence in his country. Petitioner arrived in the United States and began working to provide for himself and help his family in Guatemala. Petitioner worked as a roofer and had a child which is 1 year of age. Petitioner's brother ~~and his~~ came to the United States after because of the same reason for fear. Petitioner works hard to give son the future he deserves. Petitioner has Zero criminal history in the United States or in his country. Petitioner request that this Court grant the Temporary Restraining Order so Respondent's cannot transfer Petitioner out of the Jurisdiction of the Court or from the Otay Mesa Detention Center until the Habeas Corpus is adjudicated. My health has worsen because I have developed Depression, Anxiety, and Major Stress Disorder because of the prolonged period of detention I have spent in custody and not being able to be by the side of my only son which is (ONE) year old. I have not receieved any incident reports for misbehavior since I have been detained here at

Otay Mesa Detention Center and have remained in good behavior while in ICE custody. I am requesting for this Temporary Restraining Order to be put in place so ICE won't be able to transfer me or deport me before this Habeas Corpus is adjudicated.
