Mr. Rios Silva is currently detained by U.S. Immigration and Customs Enforcement (ICE) at the Otay Mesa Detention Center, San Diego, California.

He was detained on January 26, 2026, while working as an Uber Eats delivery driver in San Diego when he was approached and intercepted by multiple ICE agent vehicles. He was detained without a warrant for his arrest. He had not committed any crime and was not engaged in any unlawful activity.

Mr. Rios Silva remains in custody despite having active pending asylum application, active work permit, and current driver's license.

Mr. Rios Silva does not pose a danger to the community nor a flight risk. His continued detention is unnecessary and causes irreparable harm to his family.

WHEREFORE, Petitioner respectfully requests that this Honorable Court grant this Petition and order his immediate release from ICE custody while his immigration proceedings continue.
