**PETITION FOR WRIT OF HABEAS CORPUS AND REQUEST FOR FEDERAL BOND HEARING
INTRODUCTION**

Petitioners challenge the legality of their continued detention under the Due Process Clause of the Fifth Amendment.

I. JURISDICTION

This Court has jurisdiction pursuant to 28 U.S.C. § 2241 because Petitioners are in custody within this district.

II. CUSTODY STATUS

Petitioners are detained at Eden Detention Center under ICE authority.

III. ARGUMENT

A. Prolonged Immigration Detention Violates Due Process

Under Zadvydas v. Davis and Jennings v. Rodriguez, prolonged detention raises constitutional concerns.

B. Lack of Individualized Bond Determination

Due process requires a meaningful opportunity to be heard.

C. Petitioner Is Not a Flight Risk or a Danger

Petitioner does not pose a danger to the community and has demonstrated a willingness to comply with all legal requirements.

Petitioner intends to comply with all court appearances and any conditions of release imposed by this Court.

Additionally, Petitioner is actively working to secure housing and community support upon release.

D. Continued Detention Serves No Legitimate Purpose

Continued detention becomes punitive and unconstitutional.

IV. RELIEF REQUESTED

1. Immediate custody review
2. Federal bond hearing
3. Release under appropriate conditions
