**STIPULATED MOTION TO
EXTEND TEMPORARY
RESTRAINING ORDER AND
[PROPOSED] ORDER**

Noting Date: May 8, 2026

14 On April 24, 2026, Petitioner Rosa Padilla Paz filed the petition for a writ of habeas
15 corpus in this matter, seeking her release from custody. Dkt. 1. The same day, she filed a motion
16 for a temporary restraining order (TRO). Dkt. 2. Respondents responded to the TRO motion on
17 April 26, Dkt. 10, and Petitioner filed a reply on April 27. On April 29, 2026, the Court granted
18 the motion, ordering Petitioner's release and instructing Respondents not to re-detain Petitioner
19 "pending resolution of the petition for writ of habeas corpus without prior approval from the
20 Court." Dkt. 13 at 16. The Court's order provided that the TRO would remain in effect for 14
21 days. *Id.*

22 The parties agree and stipulate to an extension of the TRO for the duration of this case.
23 Good cause exists to extend the TRO, as this petition will be fully briefed as of the same day that

1 the TRO expires. A short extension of the TRO while this Court issues a final decision in this
2 matter will therefore avoid duplicative briefing and preserve both the parties' and the Court's
3 resources.

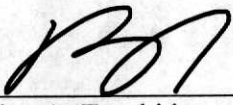
