Queries in Department of Homeland Security (DHS) databases indicated that FLORES DURAN, Jesus warranted further investigation by the local ICE office. Deportation Officer (DO) LEAL at the PERC lodged a Request for Advance Notification of Release, Form I-247G. Deportation Officers at Enforcement and Removal Operations (ERO) St. Paul reviewed the I-247G, conducted records checks and determined FLORES DURAN was deportable and probable cause existed to issue an Immigration Detainer, Form I-247A]. Supervisory Detention and Deportation Officer (SDDO) Holien issued a Warrant for Arrest of Alien, Form I-200. On April 14, 2026, DO Ward responded to Dakota County Jail, identified himself as an immigration officer, served the I-200, placed FLORES DURAN under arrest without incident, and transported to the Freeborn County Jail for ICE direct booking and administrative processing. ALIENAGE AND REMOVABILITY: FLORES DURAN is a citizen and Native of El Salvador. FLORES DURAN makes and appears to have no claim to U.S. citizenship or current lawful immigration status and is a deportable alien.

FLORES DURAN is amenable to removal from the United States under section 212a6Ai of the Immigration and Nationality Act as amended having entered the United States without inspection at a port of entry other than designated by the Attorney General of the United States and section 212(a) (7) (A) (i) (I) of the Immigration and Nationality Act (Act), as amended, as an immigrant who, at the time of application for admission, is not in possession of a valid unexpired immigrant visa, reentry permit, border crossing card, or other valid entry document required by the Act, and a valid unexpired passport, or other suitable travel document, or document of identity and nationality as required under the regulations issued by the Attorney General. IMMIGRATION HISTORY: On September 3, 2018, FLORES DURAN entered the United States without inspection at Hidalgo, Texas. On September 3, 2018, FLORES DURAN was apprehended by the United States Border Patrol and was served a Notice to Appear, I-862. CRIMINAL HISTORY: On April 11, 2026, the Lakeville Police Department arrested FLORES DURAN for driving while impaired. This case has a pending conviction. Court case number 19AVCR264852. HEALTH AND HUMANITARIAN: FLORES-Duran claims and appears to be in good health. [REDACTED] FAMILY: FLORES-Duran claims to be sign and has no children. FLORES-Duran claims his parents are citizens of El Salvador. Subject claims his parents have status here in the US. DOCUMENTS: FLORES-Duran claims he has an El Salvador passport and his house in Lakeville, MN. MILITARY SERVICE: FLORES-Duran claims to have never served in the U.S. Military or any foreign military and to have no military training. FLORES-Duran claims to have no immediate family members with current or prior U.S. Military service. 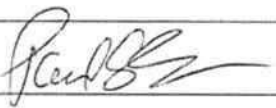
