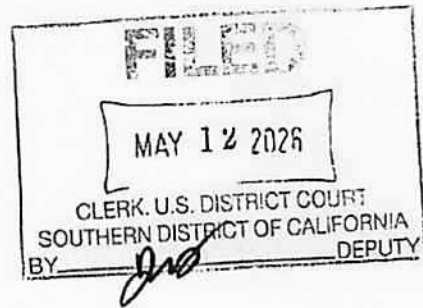

Mr. Cipres Flores is currently detained by U.S. Immigration and Customs Enforcement (ICE) at the Otay Mesa Detention Center, San Diego, California.

Mr. Cipres Flores was detained on December 6, 2025, after departing from his place of employment, when he agreed, as a favor to a friend, to provide transportation to a few individuals. At the time, Mr. Cipres Flores had no knowledge that the individuals he was transporting were undocumented.

The petitioner had previously been granted bond; however, bond was subsequently denied due to prior counsel's failure to appear at the scheduled hearing.

Mr. Cipres Flores resides in the United States and does not pose a danger to the community nor a flight risk. His continued detention is unnecessary and unjustified.

WHEREFORE, Petitioner respectfully requests that this Honorable Court grant this Petition and order his immediate release from ICE custody while his legal proceedings continue.
