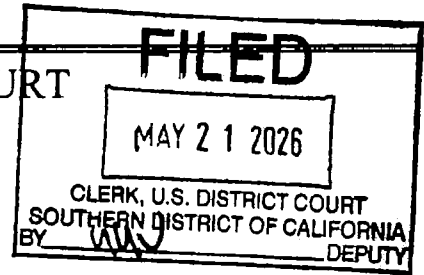

I HAVE EVER SINCE BEEN LIVING IN THE UNITED STATES WITHOUT VIOLATING THE CONDITION OF MY PENDING ASYLUM APPLICATION. I WAS ARRESTED BY ICE ON 04/25/2026 AT A MILITARY BASE WHEN I WAS TRAVELLING WITH MY FAMILY TO A OCEANSIDE BEACH AND I WAS DETAINED.

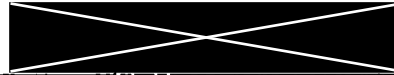
