1 On June 26, 2026, Petitioner filed a Petition for Writ of Habeas Corpus under 28
2 U.S.C § 2241, seeking an order requiring Respondents to release him from immigration
3 detention or to provide an immigration bond hearing. Dkt. 1. The Court, on June 26,
4 2026, entered the Notice of General Order 26-05 and Briefing Schedule, thereby
5 adopting the standard procedures and briefing schedule under the General Order. Dkt. 7.

6 The Respondents are not presenting an opposition argument at this time. Should
7 the Court enter relief, judgment may be entered, and consistent with the “expeditious
8 resolution” of § 2241 Immigration Petitions required by the General Order, no more
9 filings or proceedings will be necessary in this matter.
